## Policies and Agreement



### Refund Policy for Memberships

Refunds are not available for memberships. On a case by case basis, after receipt in writing to the Club Manager, the Board of Directors will review refunds or credits due to medical reasons only. Decision of the board will be final and provided within 30 days. The following guidelines for refunds will be applied:

- a) Full membership fee will be reimbursed for the current golf season/year up to April 30
- b) 50% of membership fee will be reimbursed up to June 30.

Note: No refund, in any case, will be provided after July 1. Management has the right to refuse and refund membership to anyone.

### Yearly Cart Membership Agreement

#### **Terms and Conditions:**

- Cart Lease valid between the start of the golf season until carts are returned.
- Must be paid in full before any use (non-refundable & non-transferable).
- Person leasing the cart must have a valid driver's license.
- No person under the age of 18 will operate the cart.
- Maximum 18 holes per day.
- Tournaments not included.
- Advance booking recommended to ensure availability.
- This lease limits you to ONE seat on the cart. Any other rider must have a similar lease, or must PAY the regular per-use cart fee at the Pro Shop counter prior to play.
- Return cart to front of building upon completion of play.
- Course conditions (ie. Wetness) may result in Greens Superintendent's decision to keep carts off the course. Please respect this decision.
- Carts are required to be in 15 minutes before sunset.
- The Golf Club is not responsible for any injuries incurred while using the cart.
- For groups of 3 or 4- no more than 2 carts will be allocated. For groups of 2 - no more than 1 cart will be allocated. Unless other restrictions and rules are applied.
- If you need a handicap flag for your cart, we will require either a note from your Doctor advising you are unable to play golf without one...or a valid motor vehicle handicap permit.
